On the docket being the request of granting judicial personality to the Association of Romania's Electrical Engineers.
Prosecutor's Office being represented by Popescu George, Prosecuting Attorney.

The clerk of the meeting made the report of the cause, stating that the necessary writings according to the legal dispositions have been deposited.

The official of the Association asked that the Instance should grant judicial personality and to register the Association in a special registry.

The official of the prosecutor's office concluded the admission of the request as all the conditions established by the normative papers correspond.

The Instance

By the request registered on the 25th of September 1990, the founding members of the Association of Romania's Electrical Engineers solicited the granting of judicial personality and registration in the judicial persons registry.

Besides the papers of the file (official constitutional report, the copy of the functioning status, the proof regarding the financial ways and the note given by the Ministry of Electronic and Electric Industry) the Instance decided that the Association formed on the 8th of May 1990 having as an aim the coordination of the activities of its members for the increasing of the role and the efficiency of this activity socially, economically, culturally, etc.

Following that, the Instance appreciates that all the conditions imposed by the Law No. 8 of the 3rd of December 1989 belonging to F.S.N., the Decree 31/1954, Law No. 21/1924 and seeing that the number of the members is over 20, the request will be approved.

FOR THESE REASONS,
IN THE NAME OF THE LAW
IT IS DECIDED

On the basis of the 32 Article from the Decree 31/1954, art. 84 from Law 21/1924 approves the request of registration as judicial person of the Association of Romania's Electrical Engineers, having the headquarters in Bucharest, Splaiul Independentei nr. 313, sector 6, building EA, Room EA 119.



Gives judicial personality to this institution.

The Association must respect the clauses of the 93 article from Law 21/1924 in order to declare at the Instance's clerk any changes in the constitution of the administration and ruling organs; the changing of the headquarters; any replacement or appointing of a person from the board; any altering of the status and generally the organizing or the purpose of the judicial person; the ceasing, the dissolving and the clearing of the judicial person.

The appeal can be made in 10 after the delivery

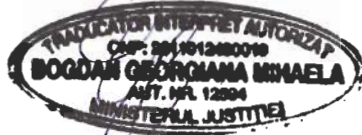
